Participant further releases the Club from any claim whatsoever on account of first aid treatment or service to me or any minor in my care during any Club activity, event, or function.

In the event any claim, action, or suit is brought against the Club, its board members and officers, any other members or participants by the Participant or any minor in the care of the Participant, the Participant hereby agrees to indemnify and hold the Club, its board members and officers and any other members and participants safe and harmless from claims, actions, suits, loss, legal fees, expenses, and judgments that may result.
